Official Raffle Contest Rules

OFFICIAL CONTEST RULES: By participating in this raffle, you agree that:

1. These Official Contest Rules may not be waived, modified, or supplemented except by a representative of Boys and Girls Club of Ada, a non-profit organization. No modification of these official contest rules shall be enforceable unless made by a representative of the Boys and Girls Club of Ada.
2. The raffle drawing shall be held at the Ada Municipal Airport during the afternoon of the Ada Air Expo, Saturday, June 26th. All Tickets must be purchased by 1:30 PM June 26th, 2010, to be eligible for the drawing.
3. Each ticket will be entered separately in the drawing. Each ticket has a separate and equal chance to win. The order of the prizes to be drawn include: (1)Grand Prize Nissan Titan, (2)Apple iPad, (3)Flat Screen TV, (4)Kids ATV, (5) \$1000 Savings Bond. Once a ticket has been selected as a prize recipient, the ticket will no longer be eligible for additional prizes.

Tickets purchased via the internet will have their ticket stubs inserted into the locked raffle box after they are purchased on-line. At your request, a receipt with confirmation number can be mailed to you.
7. If the winner is not present at the raffle event, he or she will be notified by telephone and certified mail within 48 hours of the event.
8. The winner must be at least 18 years of age, be a legal U.S. citizen, present a valid drivers license, and proof of insurance, in order to take possession of the Truck. Winner will be required to sign an Affidavit of Eligibility and Liability Release.
9. Winner is solely responsible for all taxes, registration, title and transfer fees, license duties, insurance and all expenses in claiming, registering and using the vehicle.
